AFFILIATION AND RECOGNITION OF COLLEGES AND INSTITUTIONS

(Under Section 35 of the Himachal Pradesh Technical University Act 2014) (Approved by the Board of Governors and the Academic Council in their meetings held on 25/7/2015 and 21/7/2015 respectively)

Short title.	1.	These Ordinances may be called the Himachal Pradesh Technical University Affiliation Ordinances, 2014.

		(a)	"Act" means the Himachal Pradesh Technical University Act, 2014;			
		(b)	"AICTE" means All India Council for Technical Education.			
		(c)	"Board" means the Board of Governors of the University;			
		(d)	"College" means an affiliated college, autonomous college and constituent college or any other college by whatever name called;			
		(e)	"Government" means the Government of Himachal Pradesh.			
		(f)	"Institution" means an institution, organization, training centre or other establishment providing teaching, research, experimentation of practical training in engineering, technology, physical and social science and includes a polytechnic;			
		(g)	"Teachers" includes Directors, Professors, Readers, Associate Professors, Assistant Professors, Lecturers in a college or University and such other persons giving instructions in a college or University as may be declared by the Statutes to be teachers;			
		(h)	"University" means the Himachal Pradesh Technical University, as constituted under this Ordinance;			
		(i)	"UGC" means University Grants Commission.

		(a)	Colleges or institutions established by the State Government or to be established in future imparting professional education in the State.
		(b)	Existing professional colleges or institutions of the State set up by a duly registered trust or society on self-financed basis provided they opt for affiliation to the University and get delinked from other University of the State to which they were affiliated earlier.
		(c)	All professional colleges or institution whenever established in future by the Government or society/trust on self-financed basis within the territorial jurisdiction of the University shall be required to get affiliated to the University after its becoming functional.

			Whenever, an academic programme of a College/Institution is affiliated to the University for the first time, only temporary affiliation shall be granted. This temporary affiliation shall be applicable for the entire period of the programme as defined in the Regulations.
		(b)	Permanent affiliation
			(i) A college is said to be permanently affiliated to the University, if it has obtained permanent affiliation at least for four academic programmes.
			(ii) The college/Institution shall be eligible for permanent affiliation after a period of ten years provided it fulfills all the conditions as laid down in the relevant ordinance.

(e)	Adequate essential civic facilities such as water, electricity, ventilation, separate toilets for boys and girls, telephone, internet, fax, transport for students and staff, etc. in conformity with the norms laid down by the AICTE/University;
(f)	Director/Principal and adequate number of teaching and non-teaching staff having qualifications as prescribed by the AICTE/UGC/University;
(g)	A library with adequate text and reference books of the proposed programmes besides two journals per subject, with book bank facility for students belonging to the Scheduled Castes, Scheduled Tribes and such other sections as may be specified by the University Grants Commission from time to time;
(h)	A multi-purpose complex having an auditorium, canteen, health center, indoor stadium, separate hostels for boys and girls as per the local requirements as prescribed by the AICTE;
(i)	Appropriate furniture for lecture/seminar rooms, canteen, laboratories, library, faculty rooms, tutorial rooms, administrative wing and auditorium of the multipurpose complex;
(j)	Adequate Laboratory equipment for meeting the requirement of curriculum and syllabi;
(k)	Adequate computers, software, internet and printers as per AICTE/PCI norms;

		(1)	The college shall be managed by a duly constituted Governing Council. The composition, functions and other conditions pertaining to the Governing Council shall be as prescribed in the Regulations.
			However, the constitution of Governing Council for government college is not mandatory.
		(m)	The Registered Society/Trust seeking affiliation shall be required to submit an affidavit as specified in Schedule-I on a judicial paper of Rs. 100/- duly sworn before an Executive Magistrate.
		(n)	Notwithstanding anything mentioned above the other terms and conditions for affiliation shall be as laid down in the Act, Statutes and Ordinances of the University.

It shall record its opinion on grant of affiliation/refusal after due consideration. The final recommendations will be submitted to the Vice-Chancellor before 31 st March by the Board of Affiliation.

		(g)	Principal, adequate number of teaching and non-teaching staff has been appointed on regular basis by the Governing Body of the college/institute on the recommendations of the duly constituted Selection Committee for non-government college or by the Government for government college.
Procedure for grating permanent affiliation		(a)	The procedure for grant of permanent affiliation shall be the same as for temporary affiliation as laid down under clauses 6 to 9 of this Ordinance.
		(b)	In case the University for reasons to be recorded in writing declines to allow permanent affiliation to any college/institute, the same shall be communicated to the college/institute with reason of rejection. The college/institute may apply again after removing the deficiencies but not before expiry of six months after the date of rejection of the earlier application.

		(g)	Enrollment less than 10 percent of the sanctioned intake for the last three consecutive years.
