Institution of full time Ph.D. Programme in Engineering & Technology, Pharmacy and Management as Himachal Pradesh Technical University, off campus Research Centre.

As per the clause 8 of chapter –II of the Himachal Pradesh Technical University Act-2015 the University is empowered to establish and maintain off campus centre as may be decided by the Board from time to time. Proposals have been received from the Director-cum- Principals from the affiliated colleges mentioned below to start Ph.D. programme in their institution as Himachal Pradesh Technical University off campus research centers.

- i. J.N. Govt. Engineering College, Sundernagar, District Mandi to start Ph.D. in Civil Engineering, Mechanical Engineering, Applied Mathematics and Chemistry. Proposal submitted is placed at <u>Annexure-19</u>.
- ii. Rajiv Gandhi Govt. Engineering College, Nagrota Bagwan District Kangra to start Ph.D. programme in Mechanical Engineering, Applied Sciences (Chemistry) and Humanities and Management (MBA). Proposal submitted is placed at Annexure-20.
- iii. Laureate Institute of Pharmacy, VPO Kathog, District Kangra to start Ph.D. programme in Pharmacy. Proposal along with proposed syllabus for Ph.D. course work and submitted is placed at Annexure-21.

The Academic Council approved the establishment of Himachal Pradesh Technical University off campus Research Centers with institution of Ph.D. Programme in Engineering, Pharmacy and Management with the direction to invite proposals/applications from the affiliated institutions to establish Research Centre . Academic Council authorized Hon'ble Vice Chancellor to constitute a committee of experts in different programmes. The constituted committees shall evaluate the proposal / applications submitted by different affiliated institution and submit its recommendations for establishment of off campus Research Centers including institution of applied Ph.D. programmes.
