Item No. 6.9 Hiring of Residential Accommodation for Statutory officers of the University on lease basis.

The item was discussed in detail and it was decided that Type-IV residential accommodation to all the statutory officers of H.P. Technical University viz. Registrar, Finance Officer and Deans may be hired on lease basis at a rate not exceeding Rs. 7,000 (Rs. Seven thousand) per month. However, the standard license fee as applicable for Type-IV accommodation at Hamirpur shall be recovered from the officers concerned.

Item No. 6.10 Purchase of closed body secrecy vehicle for exam related works.

The item was discussed and in view of difficulties faced in H.P. Technical University for transporation of examination related material, proposal for purchase of Mahindra make closed body secrecy vehicle is approved.
