Important Note:

- i) The Student must ensure that he/she fulfills the eligibility conditions before filling the on-line examination form for the concerned end semester examination. If found in-eligible during scrutiny, his/her examination form will be considered as cancel. Examination form once cancelled will not be re-considered and the fee paid will not be refunded under any circumstances.
- ii) Due to covid-19 pandemic all the students will be given opportunity to opt for the nearest respective HPTU examination centre and the examination centre once allotted to the students shall not be changed. If a candidate wants to change the examination centre, he/she has to apply to the Controller of examination with genuine reason & proof. An amount of ₹ 1000 will be charged for the change of examination centre.
- iii) For improvement of internal assessment (IA) either in theory or practical examination, students have to fill up the online examination form as per detail given , otherwise they will not allowed to appear in examination.

The Principals of all the affiliated colleges must ensure that the candidates admitted in their college fulfill the eligibility criteria as required under the HPTU norms for respective examination before forwarding the examination forms to the University.

The regular students must fill in the examination form online and retain the hard copy of the same for his /her record. Access of the examination forms of the regular students shall be given to the college by the university and the record of filled examination forms of the students will automatically be reflected on the college ID provided by the HPTU. The college may edit/rectify the record, *if required*; verify the examination form of the regular student.
