Item No 7.10 Procurement of "NOC" in light of Hon High Court's Order:-

One post of Superintendent Grade-II has been filled up for six months by engaging Shri Bhagwan Dass Sharma, retired Superintendent Gr II and two daily waged for sweeping and two for housekeeping have been outsourced. This is for information only.

Decision: The Board of Governors approved the Item.

Item No 7.12 Extension of staff engaged on contract/outsourc basis:-

Three posts of Assistant Registrar in the Pay Band of Rs. 15,600-39,100 with Rs.5400 GP stand created in this University. Out of these, two posts, ~~has~~ been filled up on secondment basis whereas one post filled up on temporarily by engaging Shri Gian Singh Jamwal, retired Assistant Registrar from HP University. The Board of Governors in its meeting held on 25.6.2012 vide item No 6.8 and 6.9 had extended six months period or till the posts of Assistant Registrar are filled up. For filling up these posts on secondment basis,

efforts are being made by circulating to the various Departments/ Universities but none has applied yet.

In addition to above Shri Bhagwan Dass Sharma, retired Superintendent Gr II has been engaged for six months. The present engagement period will expire on 12 Mar 2012.

Taking into consideration the increasing work load in the University and smooth functioning of the University offices, extension to the aforesaid Officer/official is required up to 30th June, 2013 or till the posts are filled up whichever is earlier.

Decision: The Board of Governors approved the Item.

Item No. 7.14 Approval for Memorandum of Understanding signed between National Institute of Teachers Training and Research, Chandigarh and Dr. B.R. Amedkar National Institute of Technology, Jalandhar.

Item No. 7.15 Approval of B. Tech Entrance 2013-14

The Board of Governors has not approved item and decided that the university will go by the decision of government i.e. admission in B.Tech courses shall be made through JEE (Main) only.

The Board of Governors decided to refer the matter to the Administrative Department.

Item No. 7.17 Computerization of Examination System

After detailed discussions, item is approved with a direction that a committee be constituted at University level comprising representatives of Department of Information Technology, Govt. of Himachal Pradesh and H.P. Takniki Shiksha Board, Dharamshala to finalize the tender document and other codal formalities.

Item No. 7.18 Approval of R&P Rule for various posts i.e. Senior Assistant, Personal Assistant, Private Secretary, Assistant Coordinator, Law Officer, Superintendent Grade-II, Section Officer, Assistant Registrar, System Analyst and Controller of Examinations.

The Board of Governors decided to refer the matter to the Administrative Department for further examining and approval. It was also decided that before absorption of the staff, a separate letter be written to the Government.


Item No. 7.19 Approval of Regulations for the constituents colleges of the University
