**Item No. 19.10** Approval for engagement of Retired Executive Engineer (Civil)/Sr. Assistant Engineer (Civil) temporarily as Project Officer (on stop gap arrangement) for smooth functioning of the University

After detailed discussion and deliberation, the Board of Governors authorized the Vice-Chancellor, Himachal Pradesh Technical University to engage experienced retired Executive Engineer (Civil)/Sr. Assistant Engineer (Civil) temporarily as Project Officer (on stop gap arrangement) on a consolidated salary of initial basic pay+ grade pay of the pay scale of concerned post or mutually agreed consolidated salary whichever is lower initially for a period of one year or till the regular incumbent joins or the retired Executive Engineer (Civil)/Sr. Assistant Engineer (Civil) attains the age of 62 years whichever is earlier subject to the condition that no retired officer shall be engaged on a post which is higher than the post from which he/she has retired.

## Item No. 19.11 Affiliation of BBA, BCA and MCA Programmes with Himachal Pradesh Technical University, Hamirpur from the Academic Session 2018-2019

As per Government Notification No. EDN(TE)A(1)29/2009 dated 22<sup>nd</sup> February, 2011 where all technical courses like Engineering Technologies, Information Technologies, Sciences, Management, Pharmacy and Architecture were transferred from H.P. University, Shimla to Himachal Pradesh Technical University, Hamirpur. Few courses related to Engineering, B. Pharmacy and Management were transferred from H.P. University, Shimla to Himachal Pradesh Technical University vide H.P. University Notification No. 1-592/20110-HPU(Acad) dated 28<sup>th</sup> April, 2011. Rest of the courses as mentioned above are yet to be transferred from H.P. University, Shimla to H.P. Technical University, Hamirpur as per the mandate of the State Technical University.

The Board of Governors considered the earlier Government notification and approved that the State Government be requested to transfer all remaining courses as mentioned above immediately affiliated with Himachal Pradesh University to Himachal Pradesh Technical University as per the direction and notification of the State Government, from the academic session 2018-19.

The Board of Governors also approved that the proceedings of both the above committees will be routed through and verified by the Dean (Academic)-cum-TEQIP Coordinator, Himachal Pradesh Technical University, Hamirpur (H.P.). Further, the Board approved that the Vice-Chancellor will act as Advisor and Registrar will act as co-Advisor of TEQIP Cell.

**Item No. 19.13 Approval of Action Plans already submitted to National Project Implementation Unit under TEQIP-III by the Himachal Pradesh Technical University as well as onward submission of Action Plan for the quarter ending September, 2018**

The Board of Governors approved the Action plans and Procurement Plans for the quarters from October 2017 to December 2017, January 2018 to March 2018, April 2018 to June 2018, and July 2018 to September 2018 submitted by the Himachal Pradesh Technical University to National Project Implementation Unit under TEQIP-III from time to time. 
