Item No. 28.2 To apprise the Academic Council about the 3rd Performance Audit Score of TEQIP-III project of Himachal Pradesh Technical University.

The Hon'ble Vice Chancellor, Himachal Pradesh Technical University apprised the Academic Council of the third performance audit score of HPTU's TEQIP-III project (placed as **Annexure-I**) during the meeting, accordingly all the members appreciated the university for this achievement.

Item No. 28.3 To consider and approve to start M.Tech programme in the various affiliated colleges/ off campuses of Himachal Pradesh Technical University, Hamirpur from the academic session 2021-22.

After detailed discussion, the Academic Council considered and approved to start the M.Tech programme in its two engineering off campuses i.e. HPTU Off Campus Mahatma Gandhi Govt. Engineering College, Kotla (Jeori) and HPTU Off Campus Hydro Engineering College, Bandla, Distt. Bilaspur (H.P), from the academic session 2021-22 as per the clause 6 (Eligibility Criteria) of Himachal Pradesh Technical University Ordinance No. 61 (Affiliation and Recognition of Colleges and Institutions), Chapter-IV, HPTU Ordinance No.62 (Regulations for Off-Campuses of the Himachal Pradesh Technical University) and Himachal Pradesh Technical University Act, 2014, Chapter-II, Clause-8 (Power to establish Constituent Colleges of Institutions) i.e. (1) The University shall have the power to establish and maintain such Constituent Colleges or Institutions, Off-campus Centres, Off-shore Campuses and Study Centres as may be decided by the Board from time to time. (2) The University shall exercise control over the Constituent Colleges, Off-campus Centres, Off-shore Campuses and Study Centres in respect of academic, financial and administrative matter as prescribed by the Ordinances.

The Academic Council also approved the Director/Principal of the aforesaid institutions submit the complete proposal through State Govt. to this university

Item No. 28.4 To consider and approve to start six month certification course of Performing Arts, Machine Learning and Artificial Intelligence, Big Data, Internet of Things (IoT), Forensic Science from the academic session 2021-22 through online and offline on self finance mode.
